Payment

18% BUYERS PREMIUM is added to final bid price to determine final sale price. For example: If the accepted bid is \$100, 18% or \$18 is added to make the final selling price of \$118. Please adjust your bidding accordingly.

Bidding

Our on-line auctions move quickly! If you are interested in an item, bid quickly. If you win an item in the auction you will be notified by email. ***In order to have enough time to conduct authorizations, registration must be completed at least 24 hours in before the auction.***

In order to better serve our customers, all bidders must provide their name, address, daytime phone number, and email address where they can be contacted. Bidder must call in 24 hours before bidding to give Wilson Auction a valid credit card to put on file. Wilson Auction will also try to call you to obtain this information when you register. It



is the bidder's responsibility to make sure Wilson Auction obtains this information prior to approving you as a bidder. This is to assure good communication between Wilson Auction & Realty Co., Ltd. and the bidder throughout any transactions.

It is strongly recommended that bids be placed early to avoid losing out due to an ill-timed, last minute bid. All times based on Eastern Standard Time. When a bid is placed on a lot within the last 60 seconds the ending time will automatically extend 2 minutes giving other bidders time to advance their bids.

The auction company shall not be held responsible for any "missed" bids or bids unseen by the auctioneer or software.

Automatic Bidding (max bid, auto bid, proxybid)

If another bidder already has an auto bid in place when you place your auto bid, the (2) competing auto bids will continue to increment until either the lower auto bid is maxed out; or if both auto bid amounts are the same the auto bid that was placed first will become winning position of the bid.
