- 1. All terms and conditions read day of auction take precedence over any and all printed material.**
- 2. By registering and receiving a bidders' number, bidder is accepting ALL TERMS AND CONDITIONS as noted, read, and made public, with NO EXCEPTIONS!**
- 3. In order to bid, you must have a bidder's number. To obtain one, you must show proper identification.**
- 4. For a bidder to have Pennsylvania Sale Tax Exemption status, the proper sale tax forms must be on file in our office.**
- 5. Payment for purchases must be made in cash, approved checks (if unknown to auctioneer, or out of state), credit cards (where applicable). Any check returned for NSF, will be charged \$50. In some cases, a bank letter of credit must be presented and verified.**
- 6. Any and all charges of Sales Tax and Buyer's Premiums will be stated before the bidding begins.**
- 7. Preview is at 12:00noon. As a registered bidder, you have the right to inspect any and all lots up for bid.**
- 8. Once an item is struck down to you, you, as the winning bidder are responsible for it and must secure it.**
- 9. Winning bidders must pay for all items before removing them from the premises. All items must be removed day of sale, unless prior arrangements are made with the auctioneer and unless otherwise noted. If any items from any lot are not removed, winning bidder will be a \$25 storage and removal fee. You will have 3 business days to contact and/or pick-up the items from the auctioneer after which time, they become property of the auctioneer.**
- 10. Auctioneer, Seller, or Staff and others DO NOT GUARANTEE any representations of any kind of the items or property being offered or sold as to the value, authenticity, condition, or provenance. All items are sold AS/IS, WHERE/IS.**
- 11. Absentee bids may be accepted only if a signed consent for a proxy bidder is received as well as a predetermined deposit in certified funds and/or credit card is on file. All absentee bids will be accepted and handled at the auctioneer's discretion.**
- 12. The Auctioneer is an Agent for the Seller. The staff, to include runners, merchandisers, clerks, cashiers, or any relief or backup auctioneer are not agents nor representatives of the seller or the goods being offered.**
- 13. There will be a 10% Buyer's Premium applied to all orders as well as 6% PA sales tax assessed upon checkout.**

ANY AND ALL SALES ARE FINAL! NO RETURNS, REFUNDS, OR EXCHANGES OF ANY KIND WILL BE CONSIDERED.
